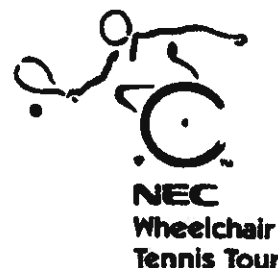

Here is what you will get with a Non-Refundable entry fee:

- Player services desks at tournament hotel and courts will be available during entire tournament. All transportation requests, updated draw schedules and updated tournament information will be available here.
- Complimentary transportation is provided only from Palm Beach International Airport and only for flights arriving or departing between hours of 9 am and 11 pm. Travel details must be received by March 25 or no guarantee of pickup.

Here is what we ask of you:

- Non-Refundable entry fee with entry form.
- Provide arrival and departure information including airline, flight numbers and times.
- Provide preferred roommates names.

Note: Players will be housed three per suite.

- 1 player per suite - extra \$90 per night
- 2 players per suite - extra \$50 per night

The special tournament rate of \$130.00 plus tax per night is available on other nights. Charges for non-players should be made payable directly to NWSF and included with entry form. Players making hotel reservations directly with Embassy Suites will not have their rooms paid for, nor be reimbursed for the tournament!

Note: Hotel room doors are 34" wide and bathroom doors are 29" wide. If your tennis wheelchair does not easily fit through these doorways, please bring your personal wheelchair. A covered and secured area at the Tennis Center will be provided for storing tennis wheelchairs.

- Provide your 2008 USA membership card. If you do not have a card and claim you have paid for 2008, a separate payment for membership will be collected before play begins. It will be reimbursed when your membership is verified.
- Coaches' Package - \$375.00 (Same amenities as Players).
- If you wish, we can provide pick-ups and deliveries at Miami airport (\$50 each way per person) and Ft. Lauderdale airport (\$30 each way per person).
