Tournament Regulations

1. All entrants must hold a valid 2008 Tennis BC membership card or enclose applicable payment to Tennis BC.
2. Players may enter a maximum of three events, one of which must be doubles.
3. Players may not enter a tournament if aware that they will be incapable of competing due to injury or other commitments.
4. Tournaments rules & regulations are as prescribed by Tennis BC in the "Yard stick". In all disputes during play, the Official Referee's decision will be final.
5. Matches will be the best of three sets. The 12 point tie-break procedure will be used at 6 games all in every set. "No Ad" scoring may be used at the discretion of the Tournament Committee.
6. A maximum 5 minute warm-up time will be strictly enforced.
7. Players are responsible for checking their own draw times.
8. Players will be expected to play when scheduled. A 15 minute default limit on all matches will be enforced.
9. Proper tennis attire must be worn on the courts. No black soled shoes.
10. Play will begin Wednesday, July 30 at 10.00 am. Weather permitting. Finals will be played Sunday, August 3, 2008
11. The Tournament Committee may cancel an event or combine events if there are insufficient entries, & may limit the draw so that all matches can be played on grass.
12. Consolations have been planned for single events only.
13. In the event of inclement weather, consolations may be cancelled or modified in order to complete the tournament. In such an event, some matches may be played on court surfaces other than grass.

- Fees must accompany forms or names will not be placed in the draw.
- No refunds will be made once name is placed in the draw.
